Parish & Town Council Elections

This nomination pack is for use by candidates who are standing at a parish/town council election on Thursday 2 May 2019

Candidates must print off the forms in this pack and submit the original signed version of each completed paper. Documents without original signatures cannot be accepted.

Nomination papers must be delivered to the Returning Officer, Brunswick Room, Guildhall, High Street, Bath, BA1 5AW, from Tuesday 19 March 2019 to Wednesday 3 April 2019, between 10am and 4pm. **The deadline to submit nominations is 4pm on Wednesday 3 April 2019.**

The following forms must be delivered by hand:

- 1a Nomination paper
- 1b Home address form
- 1c Candidate's consent to nomination

The following forms can be delivered by hand or by post:

- 2 Certificate of authorisation
- 3 Request for a party emblem
- 4 Candidate's contact details form

General Data Protection Regulation (GDPR)

Nomination paper (all candidates)	
Add the name of the ward (if the parish is warded) and the name of the parish.	
Add your full name: surname in the first box and all other names in the second.	
Optional: use the commonly used name(s) box(es) if you commonly use a name which is different from any other name you currently have. Your commonly used name will be printed on the ballot paper instead of your other name(s).	
Description: if you are standing on behalf of a political party you can use the party name or party description registered with the Electoral Commission and supported by a certificate of authorisation from that party. If you are standing as an independent candidate, you may leave this box blank, or you may use the word "Independent", or you may use a description which is not likely to lead electors to associate you with a registered political party. Whatever you enter in this box will appear as your description on the ballot paper and on the statement of persons nominated.	
Subscribers: both proposer and seconder must sign the form and have their name printed. Their electoral number can be found on the electoral register. Please explain to your subscribers what the information will be used for and that the information will be shared with the Returning Officer.	
The nomination paper must be submitted to the Returning Officer in person (but not limited to yourself) by hand, and must be accompanied by the home address form. It cannot be submitted by post, fax, email or other electronic means.	
Home address form (all candidates)

Add your full names.	
Add your home address in full.	
Add your qualifying address, or qualifying addresses.	
Indicate which of the qualifications you've declared on your consent to nomination the address or addresses relate.	
Add the full names and home address in full of the person attesting your home address form (which must be the same person as signs your consent to nomination form).	
Optional: if you do not want to have your home address printed on the ballot papers, complete Part 2 of the form, giving the name of the relevant area or, where outside the UK, the country in which your home address is situated, and sign the form.	
The home address form must be submitted to the Returning Officer in person (but not limited to yourself) by hand, and must be accompanied by the nomination paper. It cannot be submitted by post, fax, email or other electronic means.	
Candidate's consent to nomination (all candidates)	
You must be a British, Commonwealth or European Union citizen and not require leave to enter or remain in the United Kingdom or have indefinite leave to remain. You must also be 18 years old or older on the date you sign this form.	
You must meet at least one of the listed qualifications (a, b, c or d). Please delete on the form any of the qualifications which do not apply.	
Make sure that you read the Electoral Commission guidance on standing for election as well as the legislation listed. If you are not sure if you are qualified to stand you should contact the Electoral Commission or, if necessary, take your own independent legal advice.	

Add your date of birth.	
Sign and date the document in the presence of another person (who must be the same person as the attesting person on your home address form). You must not sign the consent to nomination form earlier than one calendar month before the deadline for submitting the nomination papers.	
The person witnessing your consent to nomination must sign the form and provide their name in full.	
The consent to nomination form (which must include all pages of legislation) must be submitted to the Returning Officer in person (but not limited to yourself) by hand. It cannot be submitted by post, fax, email or other electronic means.	
Certificate of authorisation (party candidates only)	
Add the name of the ward (if the parish is warded) and the name of the parish.	
The certificate must contain the candidate's full names.	
Add the name of the political party as registered with the Electoral Commission.	
The certificate must allow the use of the registered party name or registered description given on the nomination paper (or allows the candidate to choose to use the party name or any registered description).	
The certificate of authorisation must be issued by the party Nominating Officer (or someone that they have authorised to issue it on their behalf). It must be the original document signed by that person.	
The certificate of authorisation form must be submitted to the Returning Officer either in person (but not limited to yourself) or by post. It cannot be submitted by fax, email or other electronic means.	
Request for party emblem (party candidates only)	
Add the name of the ward (if the parish is warded) and the name of the parish.	
Add the name of the political party.	
Add the name or description of the party emblem registered by the party and published on the Electoral Commission's website.	
The request must be signed by the candidate and dated.	
The request for the party emblem form must be submitted to the Returning Officer either in person (but not limited to yourself) or by post. It cannot be submitted by fax, email or other electronic means.

NOTES

1. The attention of candidates and electors is drawn to the rules for filling up nomination papers and other provisions relating to nomination papers contained in the elections rules in Schedule 2 to the Local Elections (Parishes and Communities) Rules 2006.
2. Where a candidate is commonly known by some title they may be described by their title as if it were their surname.
3. Where a candidate commonly uses a name which is different from any other name they have, the commonly used name may also appear on the nomination paper, but if it does so, the commonly used name (instead of any other name) will appear on the ballot paper.
4. But the ballot paper will show the other name if the returning officer thinks that the use of the commonly used name may
 - (a) be likely to mislead or confuse electors, or
 - (b) that the commonly used name is obscene or offensive.
5. An elector may not –
 - (a) subscribe more nomination papers than there are vacancies to be filled in the electoral area in which the election is held; or
 - (b) subscribe a nomination paper for more than one ward in a parish divided into wards.
6. In this form “elector” –
 - (a) means a person whose name is registered in the register of local government electors for the electoral area in question on the last day for the publication of notice of election; and
 - (b) includes a person then shown in the register as below voting age if (but only if) it appears from the register that he will be of voting age on the day fixed for the poll.
7. However, a person who has an anonymous entry in the register of local government electors cannot nominate a candidate for election.

A candidate who is qualified by more than one qualification may complete any of those which may apply.

Local Government Act 1972**80. Disqualifications for election and holding office as member of local authority.**

(1) Subject to the provisions of section 81 below, a person shall be disqualified for being elected or being a member of a local authority if he –

(a) holds any paid office or employment (other than the office of chairman, vice-chairman, deputy chairman, presiding member or deputy presiding member or, in the case of a local authority which are operating executive arrangements which involve a leader and cabinet executive, the office of executive leader or member of the executive) appointments or elections to which are or may be made or confirmed by the local authority or any committee or sub-committee of the authority or by a joint committee or National Park authority on which the authority are represented or by any person holding any such office or employment; or

(b) is the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order, or a debt relief restrictions order under Schedule 4ZB of the Insolvency Act 1986; or

(c) [This has been removed and no longer applies]

(d) has within five years before the date of election or since his election been convicted in the United Kingdom, the Channel Islands or the Isle of Man of any offence and has had passed on him a sentence of imprisonment (whether suspended or not) for a period of not less than three months without the option of a fine; or

(e) is disqualified for being elected or for being a member of that authority under Part III of the Representation of the People Act 1983.

(2) Subject to the provisions of section 81 below, a paid officer of a local authority who is employed under the direction of –

(a) a committee or sub-committee of the authority any member of which is appointed on the nomination of some other local authority; or

(b) a joint board, joint authority, economic prosperity board, combined authority, joint waste authority or joint committee on which the authority are represented and any member of which is so appointed;

shall be disqualified for being elected or being a member of that other local authority.

(2AA) A paid member of staff of the Greater London Authority who is employed under the direction of a joint committee the membership of which includes –

(a) one or more persons appointed on the nomination of the Authority acting by the Mayor, and

(b) one or more members of one or more London borough councils appointed to the committee on the nomination of those councils,

shall be disqualified for being elected or being a member of any of those London borough councils.

(2A) Subsection (2) above shall have effect as if the reference to a joint board included a reference to a National Park authority.

(2B) For the purposes of this section a local authority shall be treated as represented on a National Park authority if it is entitled to make any appointment of a local authority member of the National Park authority.

(3) Subsection (1)(a) shall have effect in relation to a teacher in a school maintained by the local authority who does not hold an employment falling within that provision as it has effect in relation to a teacher in such a school who holds such an employment.

(5) For the purposes of subsection (1)(d) above, the ordinary date on which the period allowed for making an appeal or application with respect to the conviction expires or, if such an appeal or application is made, the date on which the appeal or application is finally disposed of or abandoned or fails by reason of the non-prosecution thereof shall be deemed to be the date of the conviction.

81. Exception to provisions of section 80

(4) Section 80(2) and (3) above shall not operate so to disqualify –

- (a) any person by reason of his being a teacher, or otherwise employed, in a school or other educational institution maintained or assisted by a county council for being a member of a district council by reason that the district council nominates members of the education committee of the county council.

Localism Act 2011

Section 34(4) describes how a person may be disqualified from standing in local government elections under this section. The remaining provisions of section 34 do not directly affect a person's entitlement to stand for election.

34. Offences

(1) A person commits an offence if, without reasonable excuse, the person –

- (a) fails to comply with an obligation imposed on the person by section 30(1) or 31(2), (3) or (7),
- (b) participates in any discussion or vote in contravention of section 31(4), or
- (c) takes any steps in contravention of section 31(8).

(2) A person commits an offence if under section 30(1) or 31(2), (3) or (7) the person provides information that is false or misleading and the person –

- (a) knows that the information is false or misleading, or
- (b) is reckless as to whether the information is true and not misleading.

(3) A person who is guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 on the standard scale.

(4) A court dealing with a person for an offence under this section may (in addition to any other power exercisable in the person's case) by order disqualify the person, for a period not exceeding five years, for being or becoming (by election or otherwise) a member or co-opted member of the relevant authority in question or any other relevant authority.

(5) A prosecution for an offence under this section is not to be instituted except by or on behalf of the Director of Public Prosecutions.

(6) Proceedings for an offence under this section may be brought within a period of 12 months beginning with the date on which evidence sufficient in the opinion of the prosecutor to warrant the proceedings came to the prosecutor's knowledge.

(7) But no such proceedings may be brought more than three years –

(a) after the commission of the offence, or

(b) in the case of a continuous contravention, after the last date on which the offence was committed.

(8) A certificate signed by the prosecutor and stating the date on which such evidence came to the prosecutor's knowledge is conclusive evidence of that fact; and a certificate to that effect and purporting to be so signed is to be treated as being so signed unless the contrary is proved.

(9) The local government Act 1972 is amended as follows.

(10) In section 86(1)(b) (authority to declare vacancy where member becomes disqualified otherwise than in certain cases) after "2000" insert "or section 34 of the Localism Act 2011".

(11) In section 87(1)(ee) (date of casual vacancies) –

(a) after "2000" insert "or section 34 of the Localism Act 2011 or", and

(b) after "decision" insert "or order".

(12) The Greater London Authority Act 1999 is amended as follows.

(13) In each of sections 7(b) and 14(b) (authority to declare vacancy where Assembly member or Mayor becomes disqualified otherwise than in certain cases) after sub-paragraph (i) insert –

"(ia) under section 34 of the Localism Act 2011,".

(14) In section 9(1)(f) (date of casual vacancies) –

(a) before "or by virtue of" insert "or section 34 of the Localism Act 2011", and

(b) after "that Act" insert "of 1998 or that section".

Certificate of authorisation

To accompany the nomination of a candidate standing on behalf of a registered political party. Please note that candidates standing on behalf of two or more parties require a certificate from each party and each must allow the same registered joint description to be used.

This certificate must be issued by the registered Nominating Officer of the party or by a person authorised to sign on their behalf.

This certificate authorises the candidate to use the exact party name as registered with the Electoral Commission, or a specific party's description as registered with the Electoral Commission, or authorises the candidate to choose either the registered party name or one of the party's registered descriptions.

This authorised party name or description can then be included by the candidate on the nomination form. It is this which will appear as their description on the ballot paper. Party names and registered descriptions are listed on the Electoral Commission's website:
