Progress on the Recreation Ground



With the weather on our side, works at the Recreation Ground have been progressing well, and the installation of the new footpaths and accessible pedestrian gates should be completed before Christmas.

Those using a mobility scooter or wheelchair will need a Radar key to open any of the accessible gates to access the Recreation Ground, and for other spaces such as Ecewiche Green and Beacon Field. If you need a Radar key, please contact the Parish Office - we can provide you with one in exchange for a £5 deposit.

Remembrance Event

The Parish Council marked Remembrance Day this year by putting up poppies around the village and with a special display outside Beacon Hall, featuring a cross to represent each of those from the Parish who gave their lives in the First and Second World Wars.

Around 30 people including members of the Parish Council also attended a secular Remembrance Event held at Beacon Hall on Sunday 14th November, with music, songs, poems and film clips.

Hedge Removal on Orchard Way



Following concerns expressed by some residents, we would like to clarify the situation regarding hedges along Orchard Way.

Since the estate around Orchard Way was built, several properties have moved their fences to the edge of the highway. Some of these have gone through planning permission and others have just actioned it, with planning enforcement following up afterwards. Many of the properties that back onto Orchard Way do own the pieces of land that the hedges are growing on, although they are meant to maintain them as a green area.

In all cases the Parish Council has objected to these hedges being removed on the grounds that it was intended that Orchard Way should act as a green corridor, and it will result in a loss of natural habitat for birds and wildlife.

However, B&NES Council Planning Department has, in recent years, taken a different view to the Parish Council and the Planning Enforcement Department has not pressed charges as they advised it was not expedient to do so. The Parish Council has followed this up with B&NES Council and spoken to many of the residents involved, but enforcement of such matters lies with B&NES Council [the Parish Council does not have the relevant legal powers].

If residents feel strongly about this issue we would ask them to contact the Planning Enforcement Department or their Ward Councillors.
