 - 1. Movement of payment for watering summer bedding planting in the absence of grounds personnel from floral displays to staffing budget, following previous president set by bringing contractors to cover works required in absence of staff.

Propose to move money for the labour of summer planting into floral display from contracted amenities approved unanimously

2. Retrospective approval is requested to enable payment of £1,845.50 for summer bedding planting payment.

Resolved to pay for summer bedding planting and delegate to the staffing committee to investigate a potential breach of governance in raising the purchase order approved unanimously

• **Decision** on a request for infrequent operational spending from the Clerk because there is now a need for five desks in the office area and to fit five desks in, we need to change some of the existing furniture. Total expenditure will not exceed £1200.00.

Proposed to delegate to Clerk with support from Staffing Committee refurbishment of the office for the staff. Allocate up to £5000 from IOE to Staffing to allow for a refurbishment of the office area. unanimous

• **Decision** to request the grant funding received from BANES in March 2024, in respect of Project Signage, be made available to Amenities and Facilities Budget as they are at the stage of approved planning and purchasing of signs.

Signage project – flagged by A&F to say given a grant by BANES – Bank account shows £4477 from BANES grant deposited for signage project. Never been moved across to committed expenditure.

Recommend by F&G that £4477 is moved from general reserve to A&F committee for the signage project committed expenditure.
